Terms of contract for Services:

***PAYMENT MUST BE MADE/CLEARED PRIOR TO ANY SET UP, WE DO NOT PLAY FIRST AND GET PAID AFTER EVENT.**

*WE ARE A LEGALLY REGISTERED BUSINESS IN THE STATE OF TEXAS, IN SAN PATRICIO COUNTY, HOME BASED IN MATHIS TEXAS.

*PAYMENT (CHECK, MONEY ORDER, OR CASH) FOR SERVICES MUST CLEAR TWO WEEKS PRIOR TO EVENT, ALL EVENTS MUST BE ON A CONTRACT TO PROTECT YOU AND SOUTH TEXAS MAFIA ENTERTAINMENT, ALSO KNOWN AS CORPUS CHRISTI SOUND & LIGHT, CORPUS-CHRISTI-DJ.COM, EDINBURG SOUND & LIGHT AND YOUR- HAUNTED-HOUSE.COM

*YOUR CONTRACT IS FOR PLAY TIME. SO IF YOU HIRE US FOR 4 HOURS THEN YOU WILL GET 4 HOURS. EXAMPLE OF WHAT HAPPENS AT A GIG. YOU HIRE US FOR 4 HOURS. WE SET UP AT 6PM AND THE DANCE STARTS AT 8PM TO 12AM (MIDNIGHT). AT 7PM YOU WANT US TO PLAY DINNER MUSIC. ONE OF TWO THINGS MUST HAPPEN, YOU PAY CASH ON THE SPOT FOR THAT HOUR, OR WE END MUSIC PLAYING AT 11PM.

*WE USE YOUR CD OR THUMB DRIVE, OR YOU DID NOT GET YOUR MUSIC LIST TO US AHEAD OF TIME, WE ARE NOT RESPONSIBLE IF IT DOES NOT WORK, OR YOU MAKE YOUR OWN QUINCEANERA/SWEET SIXTEEN/WEDDING, ETC. VIDEO AND IT DOES NOT WORK, WE ARE NOT RESPONSIBLE. WE PLUG YOUR IPOD/PHONE IN AND IT DOES NOT WORK OR CUE IN TIME, WE ARE NOT RESPONSIBLE. YOU GIVE US A VIDEO AT THE LAST MINUTE AND IT DOES NOT WORK, WE ARE NOT RESPONSIBLE. THE BEST THING TO DO IS PAY US TO MAKE IT OR GET YOUR MUSIC LIST TO US AHEAD OF TIME. IF YOU MAKE A CD AND GET IT TO US AHEAD OF TIME, WE CAN USUALLY RESOLVE ALL TECHNICAL PROBLEMS.

*WE USE PROFESSIONAL GRADE AMPLIFIERS (CROWN AND QSC) WHICH USE UP TO 11 AMPS OF POWER PER AMP. DEPENDING ON THE PACKAGE YOU PURCHASE, YOUR FACILITY MIGHT NOT BE ABLE TO SUPPORT THE ELECTRICAL NEEDS OF THE PACKAGE YOU PURCHASED. NO REFUNDS ARE GIVEN IF YOUR FACILITY CAN NOT SUPPORT OUR ELECTRICAL NEEDS AND WE NEED TO DOWNGRADE YOUR PACKAGE.

*PLEASE KNOW WHERE YOU WANT US TO SET UP THE DJ BOOTH AHEAD OF TIME AND LOOK AT THE WEB SITE FOR APPROXIMATE MEASUREMENTS OF YOUR PACKAGE. WE CAN NOT BE HELD RESPONSIBLE IF WE SET UP IN THE WRONG SPOT IF YOU ARE NOT THERE TO INFORM US AND CAN NOT BE HELD RESPONSIBLE IF WE DO NOT FINISH SET UP IN TIME. WE CAN NOT BE HELD RESPONSIBLE IF WE DO NOT FIT IN THE AREA YOU WANT US IN AND WE HAVE TO REDUCE SERVICES. NO REFUNDS ARE GIVEN IN THIS SCENARIO.

*PLEASE LET US KNOW IF WE HAVE TO BE SET UP BY A CERTAIN TIME.

*FACILITY MUST BE AVAILABLE AT LEAST TWO HOURS BEFORE (OR SET UP BY TIME), AND AFTER EVENT, SOME TIMES SET UP AND TEAR DOWN MIGHT TAKE LONGER DEPENDING ON HOW MANY TECHNICIANS ARE AVAILABLE, OR SIZE OF PACKAGE.

*SOME FACILITIES WILL CHARGE YOU FOR EXTRA SET UP AND TEAR DOWN HOURS. PLEASE REALIZE THE BIGGER THE SOUND SYSTEM PACKAGE YOU BUY, THE LONGER SET UP AND TEAR DOWN IS. OUR BIGGEST PACKAGE TAKES ABOUT FOUR HOURS TO SET UP AND THREE TO TEAR DOWN. PLEASE TALK TO YOUR FACILITY COORDINATOR TO ENSURE THEY WILL WORK WITH YOU AND THE TIME WE NEED TO SET UP AND TEAR DOWN.

*YOU MAY CANCEL YOUR CONTRACT ANY TIME ONE WEEK BEFORE EVENT. BECAUSE OF POTENTIAL LOSS OF OTHER CONTRACTS, A SERVICE CHARGE OF \$100.00 THREE DAYS OUT, \$200.00 TWO DAYS OUT AND \$300.00 ONE DAY OUT FROM PLAY DATE. ONCE WE SHOW UP AT

EVENT, START SET UP, OR "HIT THE ROAD" TO YOUR EVENT AND YOU HAVE NOT CANCELED SERVICES, A \$400.00 CHARGE WILL BE ASSESSED FROM DEPOSIT. WE ONLY CHARGE FOR PLAY TIME, NOT SET UP AND TEAR DOWN. A \$100 NON REFUNDABLE DEPOSIT IS REQUIRED UPON BOOKING YOUR EVENT.

*WE USE COMPUTERS TO DJ AND ALTHOUGH RARE, TECHNICAL PROBLEMS MAY ARISE. WE DO BRING BACKUP EQUIPMENT. IF WE CAN NOT RESTORE SERVICES YOU WILL BE REFUNDED TO THE QUARTER HOUR IN YOUR FAVOR

*SOUTH TEXAS MAFIA ENTERTAINMENT CARRIES \$2,000,000 IN LIABILITY INSURANCE TO COVER DAMAGES THAT MAY OCCUR FROM OUR MISCONDUCT OR EQUIPMENT FAILURE, WE ARE NOT RESPONSIBLE FOR YOU, YOUR GUESTS, THEIR MISCONDUCT OR ACCIDENTS CAUSE BY YOU OR YOUR GUEST, THE PREMISES YOU RENT OR YOUR PRIVATE PROPERTY OR ACCIDENTS THAT MAY OCCUR THERE , THAT IS YOUR RESPONSIBILITY.

* YOU AND YOUR GUEST MAY APPROACH THE DJ BOOTH TO REQUEST SONGS, BUT YOU AND YOUR GUEST AND ALL CHILDREN MUST STAY AWAY FROM ALL DJ EQUIPMENT. YOU AND YOUR GUEST MAY NOT LEAN ON, SIT ON OR STORE GLASSES, CUP OR BEVERAGE CONTAINERS ON ANY DJ EQUIPMENT. DJ EQUIPMENT IS VERY EXPENSIVE AND RESPECT FOR OUR EQUIPMENT IS A MUST, JUST AS WE WILL RESPECT YOUR PROPERTY AND YOUR RIGHTS. PLEASE ENSURE CHILDREN DO NOT PLAY AROUND DJ BOOTH OR EQUIPMENT.

*WE DO NOT WANT TO WORK FOR YOU IF OUT OF CONTROL PEOPLE ARE PRESENT. WE MUST PROTECT OURSELVES AND OUR EQUIPMENT, PLEASE DO NOT HIRE US IF THERE IS ANY CHANCE THAT WE WILL BE IN DANGER. WE RESERVE THE RIGHT TO LEAVE YOUR EVENT IF WE FEEL WE ARE IN DANGER OF ANY KIND WITHOUT GIVING YOU A REFUND. NO REFUNDS ARE GIVEN IF EVENT IS STOPPED BY AN ACT OF GOD/WEATHER, POLICE, ACCIDENT, DEATH, FIGHT OR ANY REASON THE EVENT IS STOPPED AFTER WE SHOW UP AND SET UP. NO REFUNDS ARE GIVEN IF YOU ARE UPSET WITH SERVICES AT THE TIME SERVICES ARE BEING EXECUTED. YOU HAVE BEEN GIVEN THE OPPORTUNITY TO SELECT YOUR MUSIC AND TIMELINE AND TYPE OF SERVICE PRIOR TO EXECUTION OF SERVICES. WE ARE PROFESSIONAL ENTERTAINMENT SERVICE PROVIDERS AND WE WILL "LIVE UP TO" OUR END OF THE CONTRACT.

*AFTER YOU SIGN CONTRACT AND WE HAVE AGREED TO PACKAGE, PRICE AND PAYMENT, AND THEN YOU CHANGE THE TERMS OF, OR MODIFY THE PACKAGE, EXAMPLE, YOU BOUGHT THE ELECTRICAL GRID BLOW OUT AT \$300 AN HOUR FOR 6 HOURS = \$1800, AND YOU ARE TOLD YOU CAN USE THE FACILITY SOUND SYSTEM AND VIDEO SCREENS, AND YOU STILL WANT US TO DJ AND DO LIGHTS, YOU ARE STILL OBLIGATED TO PAY \$1800.

*YOU ARE RESPONSIBLE TO READ THIS CONTRACT AND TO UNDERSTAND TERMS OF THIS CONTRACT WHETHER OR NOT THIS CONTRACT IS SIGNED OR EXECUTED PRIOR TO YOUR EVENT.

*ONCE CONTRACT IS FILLED OUT AND MAILED IN WITH CHECK OR MONEY ORDER, AND ONCE CHECK CLEARS, THE SIGNED ORIGINAL WILL BE SEND TO YOU AND A COPY OF THE ORIGINAL CONTRACT WILL BE KEPT FOR OUR RECORDS.
